

East Federal Way Annexation Vote Scheduled for August 21, 2007

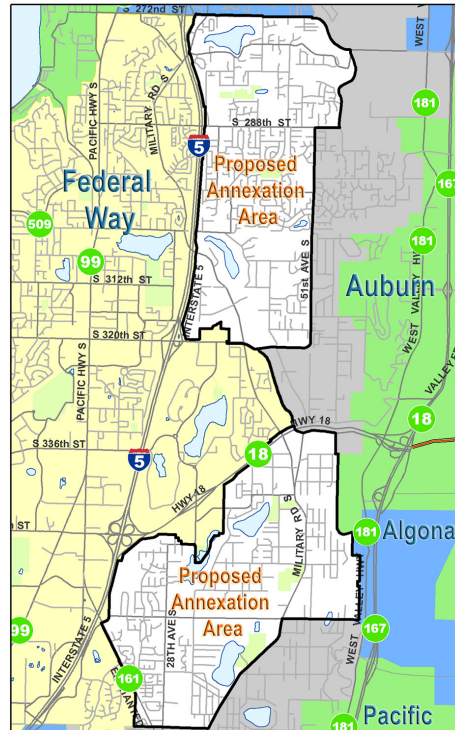

The annexation area is depicted in white on the map below. The population of this area is estimated to be just over 20,000 and the total area is approximately 4,400 acres. The area is characterized by single-family residential development at urban densities.

The City and King County are conducting a number of informational open houses over the next several months. These meetings are held at elementary schools throughout the proposed annexation area at the following times and locations:

informational meetings to help make your decision in August. If you are a member of a homeowner's association or other group located in the proposed annexation area, we would be glad to set up a special meeting with your group to discuss these issues with you.

As noted, this annexation is decided by election. Registered voters residing within the boundaries of the proposed annexation area are eligible to vote. City residents are not eligible to vote on this issue. Annexation requires a simple majority to pass.

Why is the city considering annexation of this area? People often suspect it has to do with acquiring tax revenues from the proposed annexation area. This annexation, however, does not provide a financial benefit to the City or its current residents. In fact, tax revenues generated in the annexation area are inadequate to cover the cost of providing City services to this area. The City, however, feels there are compelling reasons to proceed with annexation at this time based on a number of factors, including:

1. Crime does not respect jurisdictional boundaries. Federal Way and Auburn are seeking annexation of our respective annexation areas in part to reduce crime and to eliminate the gap in City police coverage that exists in the unincorporated island between our cities.
2. State law encourages the transition of designated urban areas from the County to the City. To accomplish this transition, the State and King County are providing subsidies to partially cover the costs associated with annexing this area. This funding is only available for large annexations initiated over the next few years. Moreover, processing one large annexation makes more efficient use of City resources than processing numerous piece-meal annexations over the next 10-20 years.
3. Development that occurs within the annexation area affects City services and City facilities, such as roads and parks. Demand for City services is expected to increase further as King County continues to cut its services.

Following annexation, the City will be able to control new development activity and to require developments to meet City standards for road improvements,

street lighting and parks.

4. The annexation area is within the same school district, the same utility district, and the same fire district as the City. Establishing consistent boundaries, to the degree possible, improves the relationship among local governments and thereby improves the efficiency of services provided by local government to taxpayers.

Restoration Underway of 373rd Street Bridge/Spring Valley

The Spring Valley Restoration Project is a joint effort between the City of Federal Way and Washington Department of Transportation which will return approximately 1,400 feet of degraded creek channel and over 16 acres of pasture-land back to its natural state. The creek will be realigned to follow a more natural, meandering path. Native trees and shrubs will provide shade cover for the stream. Additional habitat improvements will include the creation of wetland areas and placing large woody debris (i.e. stumps and logs). A major element of this project will be the construction of a new bridge on South 373rd Street to eliminate flooding across the road and improve fish and wildlife passage through this area.

While the major portion of the construction will take place this spring/summer, some preliminary work was done last summer/fall including the planting of over 500 Douglas fir and big leaf maple trees installed by over 60 Friends of the Hylebos Wetlands and REI volunteers. Additional restoration plantings are scheduled to occur in the fall of 2007.

Because this project includes significant



road improvements and the construction of a new bridge, South 373rd Street will be closed from June 23 until Labor Day weekend at the bridge. Clearly marked detour routes will be provided to serve the needs of local residents.

Two New Recycling Service Upgrades

All-in-One Curbside Recycling goes citywide in Federal Way

Recycling at home is now easier than ever! With Single Stream Recycling all recyclable items – papers, cans, cardboard, and glass & plastic bottles – get mixed together in your wheeled blue recycling cart.

Remember these simple guidelines that help sort your recyclables for end-markets:

- Keep your recycling clean (no soiled or dirty items – if in doubt, throw it out!)
- No lids, caps, or plastic bags
- Place recyclables loose in the blue cart (empty out paper bags or carriers)

Roll all your recyclables to the curb!

There's no need to set out the "Bottles and Cans" tub. Please keep your blue tub for extra recycling set-outs, or for general storage. If you no longer want the blue tub, just set it at the curb (empty) on your normal recycling day, and it will be collected and recycled.

Move up to a 96-gallon All-in-One recycling cart

There's no volume limit for recycling set-outs – if you often have extra recyclables, order a larger, 96-gallon recycling cart at no added cost. Simply call Waste Management at 253-833-3333.

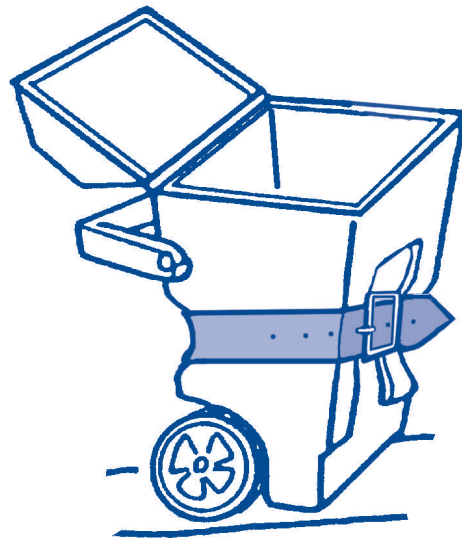
Curbside recycling comes at no additional cost with all garbage subscriptions. Garbage collection is available, starting at under \$7.00 per month at the 10-gallon "mini-can" garbage service level.

Food Scrap Recycling – Adding "Organics" to Yard Waste Carts

Another new service for yard debris subscribers is called Food+ Recycling. Federal Way residents can now add food waste and compostable paper to yard waste carts. These items make up over 30% of what is thrown out in garbage cans. Food+ Recycling means combining yard debris with:

- Spoiled fruits and vegetables and trimmings
- Coffee grounds and filters



See if you can cut down on your garbage can size and cost.

- Bread, pasta, grains
- Egg shells & nut shells
- Paper towels & napkins
- Greasy pizza delivery boxes and uncoated paper plates
- Clean shredded paper layered in yard waste (no shredded plastic window envelopes, credit cards or compact discs)
- Cheese, meat, fish, poultry, and bones
Please remember – absolutely no plastics (bags, tubs, "coated" milk cartons or ice cream boxes, coffee cups, or styrofoam) are allowed in Food+ Recycling.

Tips for Collecting Food Scraps in the Kitchen

- Kraft paper bags are ideal for 'dry' peelings – like corn husks (put the filled bag in yard waste cart – the bag composts easily).
- Use a plastic, ceramic or metal container with a tight fitting lid for 'wet' food scraps. Storing this container in the refrigerator helps avoid odor or fruit flies. Specially designed kitchen containers are available at a subsidized price for Federal Way residents – please check out www.composters.com/kingcounty for ordering details. Follow the Federal Way link, and look under "Accessories" for the "Kitchen Scrap Carrier".
- Over time, your kitchen container and yard waste cart can become messy if food residue remains after dumping. Two

tricks to avoid this: Rinse out your kitchen container after emptying, and wrap food waste in a kraft paper bag in the yard waste cart – this helps keep your cart neat.

Other ideas for avoiding potential odor or fruit flies include:

- Bury food scraps in the middle of the cart under yard waste.
- Layer yard waste or clean shredded paper on top of food scraps in your cart.
- Empty food scraps into the yard waste cart regularly – especially during hot weather.
- Wrap food scraps in newspaper layers – or place in kraft paper bags.

Think Globally & Compost Locally

The food scraps and yard waste mix becomes compost in less than sixty days at nearby Cedar Grove Composting. Yard waste and Food+ Recycling creates local, sustainable jobs. Plus, the resulting compost mixtures enrich garden soil and also help protect area surface waters.

Saving Money – Saving Landfill Capacity

Dump fees for yard debris and food scraps will continue to be lower than basic landfill fees – meaning rate savings as more residents participate – and more "organics" move to recycling. Food scrap recycling also saves capacity at our sole remaining landfill – postponing the need to export garbage to distant landfills east of the Cascades. Waste export will mean added transportation costs and higher garbage dump fees.

Movie Descriptions:

July 20, Night at the Museum
Night at the Museum is an action-adventure-comedy that comes to life by night. Good-hearted dreamer Larry Daley (Ben Stiller), despite being perpetually down on his luck, thinks he's destined for something big. But even he could never have imagined how "big" when he accepts what appears to be a menial job as a graveyard-shift security guard at a museum of natural history. During Larry's watch, extraordinary things begin to occur; Mayans, Roman Gladiators, and cowboys emerge from their diorama to wage epic battles. In his quest for fire, a Neanderthal burns down his own display, Attila the Hun pillages his neighboring exhibits, and a T-Rex reminds everyone why he's history's fiercest predator. August 17, Happily N' Ever After
Cinderella (a.k.a. Park Projects Update

West Hylebos Wetlands Park: Boardwalk Replacement (Construction Phase)

West Hylebos Wetlands Park, formerly a Washington State Park, draws visitors from around the world. The park offers a unique opportunity for recreation, exercise and education in a forested wetland, in the midst of a highly urban area. Unfortunately, the ¾ mile long boardwalk through the wetland is in a deteriorating condition. Replacing the boardwalk is key to ensuring that this valuable resource remains available to the residents of Federal Way and the region.

Construction will begin early this summer to replace the boardwalk, using long lasting materials for the foundation and deck surface. Work is scheduled to be completed by late fall. New interpretive signage for the wetlands and the historic cabins will also be installed. During construction the boardwalk portion of the park will be closed to the public. We hope to have a new, improved boardwalk for you soon.

Saghalie Park Soccer Field: Artificial Turf Installation (Construction Phase)

Work will begin in July to replace the outdated sand soccer field with an artificial turf surface. Construction will take about 4 months.



Trail and Walking Plan (Planning—Phase I)

Through this upcoming planning process the City will be asking residents for input concerning preferred walking routes and locations. The result will be to develop a series of trail and walking maps for city neighborhoods. Later phases will develop a trail master plan, and design and install trail improvements.

Update on Key Public Works Capital Projects

The following are PW Capital Projects that will be under construction between now and October 2007:

Pacific Highway S. HOV Lanes Phase III (S 284th Street to S Dash Point Rd.) This project widens Pacific Hwy. S (SR 99) to provide HOV Lanes and medians. Curb, gutter, sidewalk, planter strip, planted medians, street trees, illumination and signal modifications will be added. This project also includes the installation on traffic signal at the intersection of Dash Point Rd and Redondo Way. This project was awarded to SCI Infrastructure, L.L.C. on April 3, 2007, and construction is under way. Anticipated project completion is late October 2008.

Pacific Hwy. S. HOV Lanes (WSDOT Section)(272nd Street to S. 284th Street) This project widens Pacific Hwy S (SR99) to provide HOV Lanes and medians. Curb, gutter, sidewalk, planter strip, planted medians, street trees,

illumination and signal modifications will be added. Project design started in 2003. SCI Infrastructure, LLC is the general contractor, construction started mid July 2006. This project design, Right of Way Acquisition and construction management is under the jurisdictions of the State Department of Transportation. Contact: Messay Shiferaw, Project Engineer, (206) 768-5860. Anticipated project completion is late October 2007.

S 348th Street at Enchanted Parkway Intersection Improvements

This project will add a third left-turn lane westbound, right-turn lane eastbound, and add a third lane southbound on Enchanted Parkway to the S 352nd St/Enchanted Parkway intersection. The traffic signal will be modified to accommodate the added lanes. This project was awarded to Tucci and Sons, Inc. and construction is under way. Anticipated project completion is mid August 2007.
